 Porfilios Real Estate LLC, 2133 Brush Run Road – The township seeks condemnation and demolition of the structure on the property. Personal property needs to be removed from the premises. The property was posted by the Code Enforcement Officer on July 24, 2023.
 The Code Enforcement Officer's recommendation is to have the building demolished. Citing the owner will prolong the situation. The Code Enforcement Officer said the last issue is the owner's

- personal property; he believes the owner should be served. Mark Gordon will call Constable Bill Miller to see if he will serve the owner of the property.
- The Washington County Redevelopment Authority has provided the township with the information and list of documentation the township needs to provide to the Authority to secure funding from the Authority for the demolition of the property at 2133 Brush Run Road.
- 77 Linnwood Drive Property transfer without dye test. The property failed a dye test on July 14, 2023. A hearing was held on August 22, 2023. The property owner did not show up to the hearing. The next hearing date is the 26th of this month at 3:00 p.m.
- Washington County notified the township of plans to construct a new 911 tower site on parcel 350-004-00-00-0003-00. Information was provided to the County regarding township requirements.
 Mark Gordon believes this will be a Conditional Use. Mr. Gordon recommends knowing what companies will use the tower. McMillan will need to review the permit application when it is received.
